## Duties and Responsibilities:

Plant Health Care Technician Duties include:
Safely and accurately measure pesticides
Safely apply pesticides and fertilizers
Perform health care inspections
Interact with customers
Perform basic maintenance on the PCH truck(s) and equipment
Tree Crew Apprentice duties include:
Safely assist with tree care ground operations including hauling brush, raking, cleanup, and other assigned tasks
Learn Tree Crew procedures and skills

## Qualifications:

- Must have a valid drivers license
- Must have or be able to obtain and maintain commercial pesticide applicator license within 4 weeks of being hired
- Must have basic tree identification skills
- Must be able to work in all weather conditions

- Must be able to work independently, manage time and be an efficient production employee
- Background in caring for residential and commercial properties is a plus
- Diagnosing basic plant health issues is a plus.
